The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

ALTERNATIVE SERVICES:

DIRECT CREMATIONS: Prices range from \$2210.00 to \$2360.00
Includes local transfer of remains to funeral home, services of funeral director and staff, including custodial care and securing of necessary authorizations, basic local transportation of remains to crematory, **cremation container supplied by the customer** and return of cremains to funeral home. \$2210.00

Or includes local transfer of remains to funeral home, services of funeral director and staff, including custodial care and securing of necessary authorizations, basic local transportation of remains to crematory, **funeral home provides alternative container** for cremation and return of cremains to funeral home. \$2360.00

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers encase the body and can be made of materials like heavy cardboard, pressed-wood, or a composition material (with or without an outside covering) or may be pouches of canvas or other materials. The containers we provide are heavy cardboard.

The direct cremation prices do not include the crematory charge

Crematory charges range from \$75.00 to \$375.00

Delivery of cremains to local cemetery or as requested. \$90.00

DIRECT BURIALS: Prices range from \$2235.00 to \$3130.00
Includes local transfer of remains to funeral home, services of funeral director and staff, including topical disinfection and securing of necessary authorizations, **casket supplied by customer**, and transportation of remains to local cemetery. \$2235.00

Or includes local transfer of remains to funeral home, services of funeral director and staff, including topical disinfection and securing of necessary authorizations, **fiber board casket** and transportation of remains to local cemetery. \$3130.00

The direct burial prices do not include cemetery charges.
